**TO THE MANAWATŪ DISTRICT PLAN**

At its meeting of **16 May 2024**, the Manawatū District Council resolved to approve Plan Change 55: District Wide Rules, Plan Change 65: Outstanding Natural Features and Landscapes, Plan Change H(a): Historic Heritage, and Plan Change H(b): Notable Trees to the Manawatū District Plan pursuant to clause 17(2) of Schedule 1 of the Resource Management Act 1991 (RMA).

In accordance with clause 17(2) of Schedule 1 of the RMA, Plan Change 55, Plan Change 65, Plan Change H(a), and Plan Change H(b) to the Manawatū District Plan will become operative on **30 May 2024**.

**Plan Change 55: District Wide Rules**

Plan Change 55 was made partially operative on 26 July 2018. An appeal relating to Network Utilities in Outstanding Natural Features and Landscapes has now been resolved through finalising Plan Change 65 thereby enabling Plan Change 55 to become fully operative.

**Plan Change 65: Outstanding Features and Landscapes**

Plan Change 65 introduced amendments into the District Plan to protect the District's Outstanding Natural Features and Landscapes and Significant Amenity Features from inappropriate subdivision, use, and development.

**Plan Change H(a): Historic Heritage**

Plan Change H(a) reviewed and amended District Plan provisions relating to heritage items located outside of the Feilding Town Centre, excluding Marae Buildings.

**Plan Change H(b): Notable Trees**

Plan Change H(b) reviewed and amended provisions relating to Notable Trees listed in the District Plan.
